# **DECLARATION OF DISCLOSURE- PACKET**

You have filed your petition in your divorce or legal separation case. Now, you are ready to complete the financial disclosures needed to get divorced or legally separated. California law requires you to also complete your financial disclosures, you cannot get divorced if you do not exchange your disclosures.

The first disclosure you make is called the "preliminary declaration of disclosure." Sometimes, you also have to prepare a second or a "final disclosure". You can provide your financial disclosures at the same time as your petition if you'd like, but NO later than 60 days after filing your petition. You do NOT file your *Disclosures* with the court. You DO need to file with the court form FL-141 *Declaration Regarding Service of Declaration of Disclosure*. This form tells the court that you have given your spouse or domestic partner the preliminary and/or final declaration of disclosure.

# 1. Fill out your disclosure forms

The forms you need to fill out for your disclosures are:

- Declaration of Disclosure (Form FL-140), which is a cover sheet for your disclosures;
- Schedule of Assets and Debts (Form FL-142) or a Property Declaration (Form FL-160);
- Income and Expense Declaration (Form FL-150).
- You must also disclose, in writing, accurate and complete information about any investment opportunity, business opportunity, or other income-producing opportunity you have had since you separated, as long as that opportunity originated from an investment, business or other opportunity after you got married but before you separated.

# 2. Have your forms reviewed

Ask the court's family law facilitator/self-help center (located on the 1<sup>st</sup> Floor) to review your paperwork. If you want specific legal advice about how to fill out your disclosure documents, talk to a lawyer. The financial documents are very important, especially in cases where there is a lot of property or debt.

# 3. You will need copies

Make <u>1</u> copy of all your *disclosure* documents. The original will be for you; copy will be for your spouse. Remember your actual disclosures DO NOT get filed; you will file form FL-141 ONLY.

# 4. Provide copies to your spouse

Have someone 18 or older (NOT you) mail a copy of your disclosure forms to your spouse.

# 5. File your proof of disclosures with the court clerk

Take form FL-141 *Declaration Regarding Service of Declaration of Disclosure* to the Civil Division (located on the 4<sup>th</sup> Floor) to get filed. The clerk will keep the original and return the copy to you file stamped. This form tells the court you sent your disclosure documents as required to your spouse.

#### DO NOT FILE DECLARATIONS OF DISCLOSURE OR FINANCIAL ATTACHMENTS WITH THE COURT

In a dissolution, legal separation, or nullity action, both a preliminary and a final declaration of disclosure must be served on the other party with certain exceptions. Neither disclosure is filed with the court. Instead, a declaration stating that service of disclosure documents was completed or waived must be filed with the court (see form FL-141).

- In summary dissolution cases, each spouse or domestic partner must exchange preliminary disclosures as described in Summary Dissolution Information (form FL-810). Final disclosures are not required (see Family Code section 2109).
- In a default judgment case that is not a stipulated judgment or a judgment based on a marital settlement agreement, only the
  petitioner is required to complete and serve a preliminary declaration of disclosure. A final disclosure is not required of either party
  (see Family Code section 2110).
- Service of preliminary declarations of disclosure may not be waived by an agreement between the parties.
- Parties who agree to waive final declarations of disclosure must file their written agreement with the court (see form FL-144).

The petitioner must serve a preliminary declaration of disclosure at the same time as the Petition or within 60 days of filing the Petition. The respondent must serve a preliminary declaration of disclosure at the same time as the Response or within 60 days of filing the Response. The time periods may be extended by written agreement of the parties or by court order (see Family Code section 2104(f)).

#### Attached are the following:

- 1. A completed *Schedule of Assets and Debts* (form FL-142) or A *Property Declaration* (form FL-160) for *(specify):* Community and Quasi-Community Property Separate Property.
- 2. A completed *Income and Expense Declaration* (form FL-150).
- 3. All tax returns filed by the party in the two years before the date that the party served the disclosure documents.
- 4. A statement of all material facts and information regarding valuation of all assets that are community property or in which the community has an interest (*not a form*).
- 5. A statement of all material facts and information regarding obligations for which the community is liable (not a form).
- 6. An accurate and complete written disclosure of any investment opportunity, business opportunity, or other income-producing opportunity presented since the date of separation that results from any investment, significant business, or other income-producing opportunity from the date of marriage to the date of separation (*not a form*).

# INFORMATION AND INSTRUCTIONS FOR COMPLETING FORM FL-160

Property Declaration (form FL-160) is a multipurpose form, which may be filed with the court as an attachment to a *Petition* or *Response* or served on the other party to comply with disclosure requirements in place of a *Schedule of Assets and Debts* (form FL-142). Courts may also require a party to file a *Property Declaration* as an attachment to a *Request to Enter Default* (form FL-165) or *Judgment* (form FL-180).

### When filing a *Property Declaration* with the court, do not include private financial documents listed below.

#### Identify the type of declaration completed

- 1. Check "Community and Quasi-Community Property Declaration" on page 1 to use *Property Declaration* (form FL-160) to provide a combined list of community and quasi-community property assets and debts. Quasi-community property is property you own outside of California that would be community property if it were located in California.
- 2. Do not combine a separate property declaration with a community and quasi-community property declaration. Check "Separate Property Declaration" on page 1 when using *Property Declaration* to provide a list of separate property assets and debts.

#### **Description of the Property Declaration chart**

Pages 1 and 2

- 1. Column A is used to provide a brief description of each item of separate or community or quasi-community property.
- 2. Column B is used to list the date the item was acquired.
- 3. Column C is used to list the item's gross fair market value (an estimate of the amount of money you could get if you sold the item to another person through an advertisement).
- 4. Column D is used to list the amount owed on the item.
- 5. Column E is used to indicate the net fair market value of each item. The net fair market value is calculated by subtracting the dollar amount in column D from the amount in column C ("C minus D").
- 6. Column F is used to show a proposal on how to divide (or confirm) the item described in column A.

Page 3

- 1. Column A is used to provide a brief description of each separate or community or quasi-community property debt.
- 2. Column B is used to list the date the debt was acquired.
- 3. Column C is used to list the total amount of money owed on the debt.
- 4. Column D is used to show a proposal on how to divide (or confirm) the item of debt described in column A.

### When using this form only as an attachment to a Petition or Response

- 1. Attach a *Separate Property Declaration* (form FL-160) to respond to item 9. Only columns A and F on pages 1 and 2 and columns A and D on page 3 are required.
- 2. Attach a *Community or Quasi-Community Declaration* (form FL-160) to respond to item 10, and complete column A on all pages.

#### When serving this form on the other party as an attachment to Declaration of Disclosure (form FL-140)

- 1. Complete columns A through E on pages 1 and 2, and columns A through C on page 3.
- 2. Copies of the following documents must be attached and served on the other party:
  - (a) For real estate (item 1): deeds with legal descriptions and the latest lender's statement.
  - (b) For vehicles, boats, trailers (item 4): the title documents.

  - (g) For profit-sharing, IRAs, deferred compensation, and annuities (item 13): the latest statement.
  - (h) For each account receivable and unsecured note (item 14): documentation of the account receivable or note.
  - (i) For partnerships and other business interests (item 15): the most current K-1 and Schedule C.
  - (j) For other assets (item 16): the most current statement, title document, or declaration.
  - (k) For support arrearages (item 21): orders and statements.
  - (I) For credit cards and other debts (items 23 and 24): the latest statement.
- 3. Do not file copies of the above private financial documents with the court.
