**Madera County Superior Court's Continuing Plan to Mitigate the Spread of COVID-19**

**Press Release Addressing:**

- 1) ***Twenty-sixth (26<sup>th</sup>) General Order of Presiding Judge Ernest J. LiCalsi, which continues the provisions outlined in the Court's Twenty-fifth (25<sup>th</sup>) General Order and provides notification about a reduction of services through February 15, 2021. Please note that February 12 and 15, 2021 are Court Holidays.***
- 2) ***January 13, 2021 Emergency authorization issued by the Honorable Tani G. Cantil-Sakauye, Chief Justice of California and Chair of the Judicial Council, which is effective through February 15, 2021.***

Effective immediately, the Presiding Judge of the Madera County Superior Court issues the attached Twenty-sixth (26<sup>th</sup>) General Order, dated January 28, 2021. **Please read the General Order in its entirety to determine the level of impacted Court services.**

In addition, to continuously adhere to the directives of State and local public health officials, the following is to be considered:

- No one who is ill with symptoms of COVID-19 is to appear at the courthouse. ***All*** persons desiring entry into the courthouse will be asked health screening questions, and those allowed entry to submit filings or conduct other authorized business ***must properly wear a mask/face covering at all times and must maintain at least six (6) feet of distance between themselves and other persons.*** If an individual is denied entry, they are to contact the Court for additional guidance.
